



## Classic Rajasthan Tour

### Jaipur – Jodhpur - Udaipur



#### Day 01: Delhi - Jaipur (250 kms | 5 hrs)

Morning pick up from hotel and Drive to Jaipur. Upon arrival Check-in the hotel and freshen up. Later in the day Visit the **Amber Fort**. Enjoy the jeep ride to reach the fort. Explore the fort's stunning architecture and enjoy panoramic views.

#### Day 02: Jaipur - Jodhpur (340 Km, 6 hrs. drive)



Overnight: Stay in Udaipur.

#### **Day 06: Udaipur - Delhi - Departure**

Morning after breakfast (as per the flight schedule) check out from hotel and transfer to Udaipur Airport to board your flight to Delhi. Tour terminates on arrival.
